

## **WHATCOM COUNTY FIRE PROTECTION DISTRICT #21**

### **Resolution 2021-05**

#### **A RESOLUTION OF THE BOARD OF COMMISSIONERS OF WHATCOM COUNTY FIRE PROTECTION DISTRICT #21 DECLARING THE FOLLOWING TURNOUT GEAR SURPLUS:**

**WHEREAS**, Whatcom County Fire Protection District #21 (“the District”) has received a request to sell two (2) sets of bunker gear (Exhibit A) to the City of Bellingham.

**WHEREAS**, The proposal was made by the Bellingham Fire Department and Battalion Chief Brody Loy for members who left the District to pursue paramedicine with the Bellingham Fire Department.

**WHEREAS**, the afore-mentioned inventory was purchased by the District in 2017 and had a maximum ten (10) year life span, as described in WAC 296-305 and NFPA 1971, and,

**WHEREAS**, the bunker gear has a five (5) year shelf life remaining and,

**WHEREAS**, the afore-mentioned bunker gear has an agreed-upon value of \$1100.00 per set, and

**WHEREAS**, the staff is recommending to the Board of Fire Commissioners that the items be identified as surplus and sold to the City of Bellingham for those former District members who relocated to the Bellingham Fire Department to pursue paramedicine and,

**WHEREAS**, the Board of Fire Commissioners concur with the recommendation of staff, and

**NOW THEREFORE BE IT RESOLVED** that the Board of Fire Commissioners hereby declares the above-described items surplus, and

**BE IT FURTHER RESOLVED** that staff will invoice the City of Bellingham for the sale of the afore-mentioned bunker gear in the amount of \$2200.00, in accordance with all applicable statutes.
